However, contributions or gifts to this organization are not deductible as charitable contributions for Federal income tax purposes, since your association is a Section 501(C) 6 non-taxable entity under IRS Code.

**For Contractors:**

National dues will be \$46.50 a month, State dues \$75.00 a month (includes free enterprise \$15.00), and local dues \$83.50 per month, **\$205.00 a month**. Associate and Affiliate Members are **\$195.00** a quarter.

If at anytime you should cancel your membership, a letter of resignation must be sent to the PHCC office and the dues must be paid current. PHCC 135 Lindbergh Ave #C, Livermore, CA 94551.

Dues to PHCC-NA, PHCC-CA and PHCC-local are not deductible as a charitable contribution, but may be considered as an ordinary and necessary business expense. However, a portion of PHCC-NA and PHCC-CA dues is not deductible as a business expense to the extent that PHCC-NA and PHCC-CA engages in lobbying. The non-deductible portion of dues for 2014-2015 is five percent (5%).
